Wells Fargo

- 2,000,000 false accounts
- 5,000 employees fired
- **2011** 2015
- Concerns had been raised



- Breakdowns in internal controls
- Ineffective but reassuring controls
- "Blindspots"
 - information
 - Social engineering
 - Trusted grandmothers & superheroes
 - Management attitudes/actions

Volkswagen

- Software to defeat testing 1370 sec.
- Nitrogen Oxide 40 X limit
- 20 deaths per year
- 45,000 tons of Nox
- From 2009 to 2016
- 6 generations of defeat devices
- 40+ employees destroyed evidence



Volkswagen

- "It wasn't an ethical problem. I can't understand why you say that?"
- "We had not the right interpretation of the America law."
- "We didn't lie. We didn't understand the question."



Volkswagen

- "Fines only a moderate risk"
- "Fines in this amount [\$91 per vehicle] are not even remotely capable of influencing the share price of a globally operative company such as Volkswagen."
